The Rotuma Day Celebration was cancelled due to uncertainty in pandemic times that the FRA will need to consider. As for the FRA Backyard Farmers Root Crop Competition was held in May 2022.

The review of Strategic Plan 2021 – 2024 and Constitution was endorsed on 27 November 2021 at the Annual General Meeting.

FRA Council and Secretariat met with the Rotuman Community in the Western Division, Fiji on 16 July 2022 in Nadi and it was worth the effort.

The Secretariat and Committee, acknowledged that a broad and diverse pool of talent is essential to deliver our strategies and make a positive impact on the Rotuman society and the Association as a whole. To us this means a workforce compromised of skilled professionals from diverse backgrounds.

4.0 FRA CERTIFICATE OF INCORPORATION AND REGISTERED APPLICATION

Early this year 2022, the Registration of Titles Office disseminated a notice to FRA however this was not received from FRA office as the notice was disseminated to the former Trustees of the Association however, the Secretariat and the Council was not been advised of this notice. As a result, FRA was deregistered in January 2022.

With FRA's close working relationship with the Council of Rotuma, FRA wrote to the Office of the Prime Minister in regards to the Goundar Shipping stoppage of Franchise shipping service to Rotuma.

I write as Chairman of the Fiji Roluman Association (FRA) to seek your assistance and intervention towards the decision by the Goundar Shipping Company on 6 June 2022 to cease all trips to Roluma and Lau due to the rise in Fuel prices. This is of great concern to our people as we fully rely on Government to provide shipping services to our people on the island. Of the ten (10) Government franchise shipping routes In Fiji. Roluma is one of them serviced by Goundar Shipping. The questions 17 di like to pose is why are we being victimised when the increase in tuel price is of a global issue? What is Government's stance on the decision made by Goundar Shipping to cease its services to Roluma? We are not privy to the Franchise Agreement but it appears that Goundar Shipping has the discretion to decide on whether it should or should not run its ships when cost becomes a concern. The hike in fuel price which is the main reason for ceasing the shipping to resort to such drastic actions where the livelihood of people is compromised. I have just returned from Rotuma last week and have noted the shortage of testingtions on the island. Shops have run out of fuel sugar, milk, flour and toleties to name a few. Of course there is abundance of root crops, veges and sea food, however people rely on essential items for daily use especially the children.
